5. I will learn the strengths and weaknesses of my players so that I might place them into situations where they have a maximum opportunity to achieve success.
6. I will conduct my practices and games so that all players will have an opportunity to improve their skill level through active participation.
7. I will communicate to my players and their parents the rights and responsibilities of individuals on our team.
8. I will cooperate with the administrator of our organization in the enforcement of rules and regulations, and I will report any irregularities, which violate sound competitive practices.
9. I will protect the health and safety of my players by insisting that all of the activities under my control are conducted for their psychological and physiological welfare, rather than for the vicarious interests of adults.

I am aware the Board reserves the right to appoint coaches to the teams that they believe will be in the best interest of the players and Mount Pearl Minor Hockey Association.

I am aware of, and agree with, the fact that any behavior on my part which could be contrary to the above aims would forfeit my coaching privileges.
